



Clinical Leadership in Safeguarding 2 Days - Virtual Classroom

This course is designed for all safeguarding leads with operational accountability for safeguarding children and adults, such as Designated and Names Professionals and those who undertaking strategic Safeguarding Leads, covering both the children and adult agenda.

Covid-19 – Lessons Learnt

The course has been updated to take into consideration the impact of Covid-19 has had in regards to safeguarding children, adults and staff and will include the potential lessons learnt to assist with improved safeguarding strategies and preparation for further waves, localised outbreaks and lockdowns and winter pressures. Examples for discussion will include the disproportionate numbers of BAME contracting and dying of COVID 19, the lack of PPE, the lack of testing, the implications for care homes and psychiatric hospitals, the increases in domestic homicide and domestic abuse during lockdown, blanket policies suspending hospital, care home or prison visits, plus the rise in referrals for self-neglect, self-harm and mental health.

Course Overview

The course will explore the safety and governance of an organisation to include culture, ethos and principles underpinning safeguarding as core business with a focus on making safeguarding personal and person centred for all children, adults and staff.

Consideration will be given to the statutory duties of the NHS as a public authority with regard to public law, Human Rights and the Equality Act plus the duties and responsibilities of safeguarding partnerships regarding the Care Act 2014, the Mental Capacity Act 2005 and the Children Acts 1989 and 2004 the Children and Social Work Act 2017.

Delegates will also consider NHS duties around whistleblowing and Duty of candour, and safeguarding links to the safety of patients, staff and the organisation.

Consequences of poor safeguarding will be explored, and the implications of poor practice around records and record keeping which impacts upon could impact upon defendable decision making if there were legal challenges. The day concludes with an exploration of the Coroner's court to include a mock cross examination session.
