I am a resident of [REDACTED] Warrington. This email is to register my strong objection to the Council's Local Plan and particularly the land at Peel Hall. For almost the last 30 years this community has battled against the continual applications by Satnam Millenium to develop the land at Peel Hall. As you are aware this land is currently included in the Council's Local Plan.

Despite the campaign against the Local Plan and specifically the campaign by the community in the Peel Hall area, it appears the Council continues to ignore the Residents, the Residents who voted them into office. I say this because this is what I hear from conversations with other residents and also what I read in the local press.

I am writing to register my strong objection to the Local Plan. My reasons are:-

- The land at Peel Hall should be removed from the Local Plan. Time after time Satnam's planning applications are rejected because they are seen as lacking sustainability.
- It is the last green space in this part of Warrington. When its gone its gone.
- The latest application was for 1200 houses. This would create further transport chaos on our already under stress local transport system.
- The last proposed development would dramatically increase air pollution in an area which is one of the highest polluted areas in the country.
- Schools in the area are already over subscribed. There seems to be no sensible plan to accomodate the extra pupils that would result in building 1200 houses.
- Warrington Hospital which is already under strain would have to accomodate the extra patients generated by 1200 houses.
- Past plans show little respect for the wildlife and the environment in the Peel Hall area.

In my opinion, its about time the Council listened to the residents and remove the land at Peel Hall and step back and revise the Local Plan and remove the green land spaces that are currently included.

Stop applications by Satnam and the strain and stresses it places on your residents and revise the Local Plan.
