





I cannot support any form of development that uses green belt land when there are many brown field sites available. Given the levels of pollution we have in this country, environmental issues with flooding etc and the challenge to wild life our green belts are an essential part of any future we may have.

We are already saturated with housing and cannot sustain any further growth with the resource levels in this area.

Why are we considering a 20 year plan when 15 is more realistic particularly with the economy in such a low growth phase.

The area proposed in Appleton is totally unsuitable because of its constraining boundaries of the ship canal, M6 and M56 which have very limited options to improve any access to and from the areas. It only takes minor issues on the M56 or M6 to dramatically increase the traffic through the area causing major congestion, pollution and poor air quality.

I have lived in this area for nearly 30 years and have seen congestion and issues with resources spiral enough without signification changes in development so one cannot imagine what will happen if these developments go ahead.

This council has been totally irresponsible in the way it has ignored the limitations of the road infrastructure and resource levels for schooling and health care south of Warrington and this is proposal is a further example of the incompetent planning organisation. We cannot bury our heads in the sand over the issues raised above and which physical restrictions caused by Appletons location. In summary I believe the plan is unsound and does not recognise the fact that Appleton has reached a point where any further development in housing and industrial jobs with bring the whole area to a grinding halt.
