

Achievable plan. Warrington has been named as the most air polluted place in Britain, we are in the midst of a climate change crisis and government has a new agenda aimed at tackling this problem which leads me to believe that previous housing numbers and any plans prior to the current concerns are outdated and no longer feasible and should therefore be re-visited as a matter of urgency. A complete disregard of the potential impact upon the health and well being on local residents anticipated due to the scale of the local plan is unacceptable and I would anticipate concerns raised from lawyers in years to come regarding the health of local residents in the future if the plans go ahead. I would also like other sites such as brownfield sites (eg. fiddlers ferry) and other sites round warrington to be considered prior to this plan going ahead. The projected number of houses along side other applications such as Eddie Stobart and six56 is unacceptable and these plans need to be re-visited with more care taken in respect of joint

Up planning and thinking. I am also deeply concerned about the impact upon local public services.
