This plan is not fit for purpose and I challenge the assumptions that WBC have made, there is little evidence that this plan has been prepared properly and positively. To build houses so close to a village that will be impacted massively without any consultation with the neighbouring borough council and its residents is unacceptable.

Moore village stands to lose a substantial amount of green belt and the boundary between Warrington and Halton will become blurred. This plan will in effect merge our historic village with Warrington, we stand to lose our identity and our heritage. I invite the Inspectorate to visit our small village to understand the huge impact this development will have on our green belt, its wildlife, possible damage to of some of Moore Conservation area and the further damage this can do to the area along the Bridgewater canal.
