There is no justification in the release of green belt land at the scale suggested. The plan fails to set out any adequate transport infrastructure through South Harrington yet proposes an increase of some 4500 new properties. I believe that there is nothing within the draft local plan that would regenerate the commence of our town centre. It will only provide the council with an increase in council tax.
