Policy W4 7.1- increased traffic on Warrington Road and at the junction with Holcroft Lane. An additional 200 houses would mean a minimum of 200 additional cars using the junction of Warrington rd/Holcroft Lane. The road is already logjammed at peak times, especially when Culcheth High School starts/finishes. The problems are compounded by parents at Culcheth primary School using Warrington Rd as a car park. The homeowners will not use public transport. Most family houses in Culcheth have 2 cars, as the public transport is infrequent and unreliable. Trains through Birchwood do not link with the buses. Most people who live here drive to the M62/M6. Additional road traffic does not fit with the Government's aim of reducing cars on the road. The development is too far from the village centre - visit it on a Saturday morning, cars parked on pavements in inappropriate places, causing obstructions. Please provide details of the additional public transport other than a 19 bus every 2 hours that sits in traffic as we don't have a dedicated bus lane. Additional cars on the road will cause more air pollution for the residents of Warrington Road. Will there be a cycle lane built from the development to the village centre?

7.4 There is one Doctors surgery to serve the residents of Culcheth, Croft and Glazebury. It isn't enough to service the current population. As people are living longer, the demands placed on the surgery by an ageing population will increase. Without using private transport it's impossible for the elderly of Culcheth to access Warrington Hospital. There is only one NHS dentist that has a long waiting list for NHS patients. If a % of affordable housing is built, I assume that these people will not be able to access private care and so will place more demands on the overstrained NHS facilities.

Not sound

There are alternative sites around Warrington and in Culcheth - brownfield- that would meet some housing needs.

Culcheth is on the edge of Warrington, many residents actually shop in Leigh, which is nearer, rather than travel to Warrington centre. I doubt that the residents of any new housing development will come from Warrington, they are more likely to move into the area, placing further demand on the town's facilities and hospital. The public transport links from Culcheth are appalling. If you want to get a train, you have to drive to Birchwood as the 28 bus is infrequent and unreliable. There is no bus to Newton station. This means at least an additional 200 cars using the Holcroft Lane/Warrington rd junction at peak times. This is totally against Government policy regarding climate change. We have one GP surgery and one NHS dentist within a radius of at least 7 miles. What about schools, in particular primary schools? The main admission criteria is nearness to school - if there are at least 200 x 2 children on this estate, that is enough to fill one primary school. What about the children from the other houses in the village, will an additional school be built to accommodate them?
