If each home had two cars that would have an impact of a further 8,000 plus vehicles as well as added pollution. The current plan is vague and lacks concrete data which indicates that there will always be insufficient infrastructure in place.

This is evident for commuters and residents using the A49, A56 where the flow of traffic is unable to cope with the current road system. Furthermore, the old bridges in use where never designed to cater for the volume of traffic in this the 21st century.
