**THE BOROUGH OF WARRINGTON (OFF-STREET PARKING PLACES) (CIVIL ENFORCEMENT) CONSOLIDATION**  
**(AMENDMENT NO. 8) ORDER 2024**

**NOTICE IS HEREBY GIVEN** that the Council made an Order under Sections 1, 2, 4, 32, 35 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 and of all other enabling powers on 26<sup>th</sup> June 2024. The effect of the Order is The Borough of Warrington (Off-Street Parking Places) (Civil Enforcement) Consolidation Order 2018, is hereby further varied or amended as detailed in Schedules 1 and 2.

The Order will be effective from 1<sup>st</sup> July 2024.

Any person who wishes to question the validity of the Order or of any provision contained in it on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1984 or on the grounds that any requirement of that Act or any instrument made under it has not been complied with in relation to the Order may, within six weeks from 26<sup>th</sup> June 2024, apply to the High Court for this purpose.
