THE BOROUGH OF WARRINGTON (OFF-STREET PARKING PLACES) (CIVIL ENFORCEMENT) CONSOLIDATION (AMENDMENT NO. 8) ORDER 2024

The Warrington Borough Council (hereinafter called "the Council") in exercise of its powers under Sections 1, 2, 4, 32, 35 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984, as amended ("the 1984 Act") and of all other enabling powers and after consultation with the Chief Constable of Cheshire Constabulary in accordance with Part III of Schedule 9 to the 1984 Act hereby makes the following Order:

- 1. Except where the context requires otherwise, any reference in this Order to a numbered Article shall be construed as a reference to the Article bearing that number in the Order referred to in the Schedule to this Order.
- 2. Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended, applied, consolidated, re-enacted by or as having effect by virtue of any subsequent enactment.
- 3. Unless the context otherwise requires words denoting the singular shall include the plural and vice versa and words denoting the persons shall include either gender, bodies corporate, unincorporated associations and partnerships.
- 4. The Interpretation Act 1978 shall apply to the interpretation of this Order as it applies for the interpretation of an Act of Parliament and as if for the purposes of Section 21 of that Act this Order were an Act of Parliament and the Orders revoked by this Order were Acts of Parliament thereby repealed.
- 5. The making of this Order by the council is done so under the duty imposed by Section 122(1) of The Road Traffic Regulation Act 1984 to secure the expeditious, convenient and safe movement of vehicular and other traffic and the provision of suitable and adequate parking facilities on and off the Highway, insofar as practicable having regard to the matters in Section 122(2) of the said Act.
- 6. The Borough of Warrington (Off-Street Parking Places) (Civil Enforcement) Consolidation Order 2018, is hereby further varied or amended as detailed in Schedules 1, 2 and 3 to this Order.
- 7. The restrictions imposed by this Order shall be in addition to and not in derogation from any restriction or requirements imposed by any regulations made or having effect as if made under the Act or by or under any other enactment.
- 8. This Order shall come into operation on the 1st day of July 2024 and may be cited as "The Borough of Warrington (Off-Street Parking Places) (Civil Enforcement) Consolidation (Amendment No. 8) Order 2024".
