4.0 Towns Fund Programme Update

Kerry Hall reported on the Towns Fund Programme:

- The programme continues to meet milestones and deliverables, with the Construction and Civil Engineering Academy set to complete in Q2.
- Will then have four projects completed, and three in delivery.
- Stage 1 evaluations for completed projects will align with the end of Q2 (September).
- The total Towns Fund grant remains 100% committed, with spending following project timelines.
- Revised delivery schedules are in place for previously delayed projects, aligning with the overall programme schedule.
- New branding guidelines for Levelling Up initiatives have been distributed.
- A schedule for marcoms activity is being developed to support projects at varying stages.
- Progress report accepted; no issues raised.

5.0 Town Deal Project updates -

Digital Enterprise Hub

Update from Josh Downes:

- Project remains on programme and budget.
- Roofing works 85% complete and toilet and showers at first fix; targeting October for completion.
- Internal scaffold being erected next week.
- Phase 3 works commence November, with anticipated completion May 2025.
- Several temporary full-time jobs are supporting the project during construction.

Construction & Civil Engineering Academy

PART 1 – SUMMARY

Project Status

The programme continues to make steady progress towards its project deliverables. In Q2, we saw the completion of another project, bringing the total to four: the Bus Depot, Health and Wellbeing Academy, Living Well Hub, and the Construction and Civil Engineering Academy. Each of these projects has undergone the Stage 1 Evaluation as part of the two-stage project closure process. While they have achieved their deliverables, some items still require attention, such as fund claims, benefits monitoring, and stakeholder communication. The lessons learned from these evaluations will enhance future projects by identifying what worked well and what didn't, facilitating knowledge exchange for improved planning and execution.

The other three projects are in delivery, all are on track to be completed within the programme's scheduled timescales.

- **Digital Enterprise Hub:** roof works and WC improvements continue, the inclement weather has impacted works however, no overall impact to the overall project delivery timescale.
- **Pyramid Remastered:** construction works commenced 19 September and refurbishment works are underway. The construction is planned for completion December 2025 in readiness for fit out.
- Sustainable Travel: within the portfolio we continue to see project elements completing most recent drainage works for grass playing pitches. Designs have been developed for other active travel and access improvements and consultations are in process.

Financial

The council has receipted the majority of the Towns Fund. Remaining funds will be received as projects in delivery reach their milestones. While some allocated funds are yet to be utilised, 100% of the £22.1m programme funding remains fully committed.

Branding

The government's revised branding assets have been adopted and are now being utilised across all relevant projects and communications.

Monitoring & Evaluation Framework

Performance monitoring for the period 1 March 2024 to 30 September 2024, including a comprehensive risk analysis, is required. Project leads have been asked to complete the template by 30 October to allow Town Board members to review all materials during the week commencing 4 November, prior to final sign-off and upload to the portal. All projects regardless of status will complete performance monitoring on a 6 monthly basis.

PART 3 – PROGRAMME RISKS & CHALLENGES

The programme is in a stable phase, with all project deliverables progressing in line with the overall schedule. While recent inclement weather has caused delays to the external roof works at the Digital Enterprise Hub, no further/new delays have been reported across the projects.

As part of the performance monitoring process, a detailed risk analysis will be conducted for each project in delivery and the programme.

4.2 Allocation & Utilisation

The council has receipted the majority of the Towns Funding. Remaining funds will be received as projects in delivery reach their milestones. While some allocated funds are yet to be utilised, 100% of the £22.1m programme funding remains fully committed, with some projects securing additional match funding to cover increases in expenditure. All project usage and claims have been reconciled with the council's finance system (SAP). There is a variance in the usage since last reported this is due to reclassification of expenditure that will be reflected in the next update.

Health & Social Care Academy: Expenditure is showing as exceeded the award amount this is due to additional legal support required for the contract variation agreement. Currently working with Finance to reallocate the costs to an alternative budget.

Living Well Hub: The ongoing revenue fund payment schedule extends through to June 2025 to support operational activities.

Digital Enterprise Hub: In Q2, additional grant funds were released in line with the agreed payment schedule. The project grant award remains fully committed at 100%.

Pyramid Remastered: The grant award remains fully committed, and with construction work commencing on 19 September the grant utilisation will increase in the coming period.

Construction & Civil Engineering Academy: The project is now complete and has recently commenced operations. Over £0.5M in claims are currently in process for payment. The final claim will be processed in line with the retention period outlined in the grant agreement.

Sustainable Travel: Although project delivery delays and postponed consultations due to election period have affected spend, grant usage across the portfolio is continuing. The grant award remains fully committed at 100%. Compared to the August update, grant usage has temporarily decreased due to the reversal of capitalised salaries, but this will be adjusted in the next update.

Programme Management: The programme management budget is fully committed.

Financial Evidence: The Programme Manager and the Council's Audit Team have now met with representatives from all seven projects to review the evidence requirements for the funding claimed/utilised. Next stage Audit to undertake sample testing in Q4 of benefits and claims across the portfolio of projects.

PART 5 - PROGRAMME MILESTONES

Milestones delivered Q2:

- Construction & Civil Engineering Academy Project complete, facility open for education delivery.
- Pyramid Remastered Site handover to main contractor, refurbishment works commenced 19 September 2024.
- Sustainable Travel Internal consultation periods live.

Milestones planned for Q3:

- Digital Enterprise Hub Internal design works approved.
- Sustainable Travel Public consultation periods live.

PART 6 – PROGRAMME BENEFITS

Output and outcome data is currently being compiled as part of the six-monthly monitoring and evaluation process. Initial insights show positive progress across the portfolio of projects. Each project is reporting against a range of mandatory, project-specific standard, and custom indicators.

Completed projects have reported the creation of new permanent full-time equivalent jobs and the safeguarding of existing positions. They have also documented the establishment of new facilities and floor space, collaborations with employers, new training resources, and the number of learners completing courses, as well as schools engaged.

Projects currently in delivery are reporting the support of temporary full-time jobs during the delivery phase, with plans to focus on specific project outcomes once completed.





PART 7 – STAKEHOLDER MANAGEMENT & MARCOMS

During Q2, projects successfully disseminated communications across multiple channels. Key highlights included the commencement of construction works at the Pyramid on the Digital Enterprise Hub site and a notable increase in visitor numbers at the Living Well Hub.

Warrington Borough Council's Corporate Communications team is working closely with all project leads to develop communications around key milestones and achievements, supporting updates and the long-term legacy of the projects.
